

Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. The state of medical knowledge is evolving, but the virus is believed to spread from person-to-person contact and/or by contact with contaminated surfaces and objects, and even possibly in the air. People reportedly can be infected and show no symptoms and therefore spread the disease. The exact methods of spread and contraction are unknown, and there is no known treatment, cure, or vaccine for COVID-19. Evidence has shown that COVID-19 can cause serious and potentially life threatening illness and even death.

Rainbow Nursery School will follow all sanitary practices recommended by the CDC and the Kentucky Early Childhood Standards. Staff will be required to wear masks, use gloves when necessary, and check temperatures daily. Rainbow Nursery School will take every precaution to keep the students and staff healthy.

Rainbow Nursery School cannot prevent you or your child from becoming exposed to, contracting, or spreading COVID-19 while utilizing Rainbow Nursery School's services or premises. It is not possible to prevent against the presence of the disease. Therefore, if you choose to utilize Rainbow Nursery School's services and/or enter onto Rainbow Nursery School's premises you may be exposing yourself to and/or increasing your risk of contracting or spreading COVID-19.

ASSUMPTION OF RISK: I have read and understood the above warning concerning COVID-19. I hereby choose to accept the risk of contracting COVID-19 for myself and/or my children in order to utilize Rainbow Nursery School's services and enter Rainbow Nursery School's premises. These services are of such value to me and to my child that I accept the risk of being exposed to, contracting, and/or spreading COVID-19 in order to utilize Rainbow Nursery School's services and premises in person.

WAIVER OF LAWSUIT/LIABILITY: I hereby forever release and waive my right to bring suit against Rainbow Nursery School and West Broadway Baptist Church and its officers, directors, managers, officials, trustees, agents, employees, or other representatives in connection with exposure, infection, and/or spread of COVID-19 related to utilizing Rainbow Nursery School's services and premises. I understand that this waiver means I give up my right to bring any claims including for personal injuries, death, disease or property losses, or any other loss, including but not limited to claims of negligence and give up any claim I may have to seek damages, whether known or unknown, foreseen or unforeseen.

CHOICE OF LAW: I understand and agree that the law of the Commonwealth of Kentucky will apply to this contract.
